 COLLECTIVE GRANT MAKING: IN 2024 THE FOUNDATION GRANTED A TOTAL OF \$454,500 IN COLLECTIVE GRANT FUNDS TO NONPROFITS EVALUATED THROUGH A MEMBER COMMITTEE REVIEW PROCESS AND SELECTED BY MEMBERSHIP VOTE. ALL GRANTS WERE TO WASHINGTON STATE NONPROFIT ORGANIZATIONS. ROUGHLY 280 MEMBERS VOLUNTEERED THEIR TIME AND FINANCIAL RESOURCES TO THE COLLECTIVE GRANTMAKING PROCESS. MANY MEMBERS PARTICIPATED DIRECTLY IN A REVIEW PROCESS WITH GRANTEEES WHILE STUDYING THE JUSTICE AND EQUITY ISSUES THAT THE GRANTEE ORGANIZATIONS ADDRESS. THE FULL MEMBERSHIP VOTED TO SELECT THE FINAL GRANT RECIPIENTS.

THE COMPLETED 990 IS PROVIDED TO THE FINANCE COMMITTEE SUFFICIENTLY IN
ADVANCE OF THE FILING DEADLINE TO ENABLE THEIR REVIEW. IT IS THEN PROVIDED
TO THE BOARD IN ADVANCE OF THEIR NEXT BOARD MEETING SO THAT IT CAN BE NOTED
AS RECEIVED BY MEMBERS IN THE MINUTES FOR THAT MEETING. ONCE THESE STEPS
ARE COMPLETED THE FORM IS FILED WITH THE IRS.

FORM 990, PART VI, SECTION B, LINE 12C:
ANNUALLY, EACH COVERED PERSON (OFFICERS AND MEMBERS OF THE BOARD AND
MEMBERS OF ANY COMMITTEE OF WAWF WITH BOARD DELEGATED POWERS) IS ASKED TO
SIGN AND SUBMIT A CONFLICT OF INTEREST QUESTIONNAIRE DISCLOSING ANY
POTENTIAL CONFLICTS TO THE PRESIDENT AND CEO OF THE FOUNDATION. THEN, AS
APPROPRIATE, DIRECTORS ARE ASKED IF THERE ARE ANY CHANGES TO THEIR CONFLICT
OF INTERESTS THAT WOULD AFFECT THE BUSINESS OF THE FOUNDATION. ANY CHANGES
ARE DOCUMENTED IN MEETING MINUTES. ANY COVERED INDIVIDUAL WITH A CONFLICT
OF INTEREST IS REQUIRED TO RECUSE THEMSELVES FROM DISCUSSION AND DECISION
MAKING RELATED TO THE MATTER IN WHICH THEY HAVE A CONFLICT.

FORM 990, PART VI, SECTION B, LINE 15:
REGIONAL NONPROFIT SALARY SURVEYS PUBLISHED BY ARCHBRIGHT ARE CONSULTED
WHEN SETTING ALL STAFF SALARIES. THE CEO DETERMINES STAFF SALARIES OTHER
THAN HER OWN. THE BOARD DETERMINES THE CEO'S SALARY. THE ANNUAL SALARY
BUDGET IS APPROVED BY THE BOARD AS AN ELEMENT OF THE ANNUAL BUDGET THEY
VOTE UPON. THE BOARD'S BUDGET APPROVAL IS RECORDED IN THE BOARD MEETING
MINUTES.
